1. General Information for Bachelor's Degree Applicants

Submit an electronic application

Application forms will be accepted from May 1st, 2025, till July 31st, 2025. For electronic application form please use this link e-application form.

2. Admission requirements

The applicant will be admitted to the study after fulfilling the conditions of admission proceedings.

Criteria for Admission to Study in Bachelor's degree programme:

- To prove the fulfilment of the condition of achieving secondary education with a school-leaving examination.
- Arithmetic mean of study results for first year study of bachelor studies at Dong Nai Technology University, Vietnam.

The applicant must submit document (Copy of passport, Transcript of Records) as an attachment to the eapplication form in pdf format till July 31st, 2025.

The applicant must submit document that proves the fulfilment of the condition of prior education as an attachment to the e-application form in pdf format till July 31st, 2025.

The applicant has to deliver the documents in paper form by post to the address of the faculty and present as an attachment to the application in pdf format by July 15th, 2025 in the case of assessment of foreign secondary education within the admission procedure at VSB – Technical University of Ostrava. 4. Decision

The admission committee verifies an accuracy of the application and attached materials.

The decision on admission to study is made by the Dean of the Faculty in relation to the ranking of the arithmetic mean of study results for first year of bachelor studies at the Dong Nai Technology University, Vietnam (from the highest value to the lowest one up to max number of applicants to be admitted).

In accordance with the provisions of Section 50 Subsection 4 of Act No. 111/1998 Coll., on Higher Education Institutions and on the amendment to other acts (Higher Education Act), a decision on the admission or rejection of the applicant for admission must be issued within 30 days from the verification of the conditions for admission to study, not later than August 31st, 2025.

The decision on the admission will be announced via e-application with the applicant's consent.

In accordance with the provisions of Section 50 Subsection 5 of Act No. 111/1998 Coll., on Higher Education Institutions and on the amendment to other acts (Higher Education Act), applicants have the right to inspect all documents and materials that are of relevance to the decision on their admission.

In accordance with Section 50 (6) of the Higher Education Act, the applicant has the right to appeal against this decision within 30 days of its notification.

5. Enrolment

Pursuant to the provisions of Section 51 Subsection 1 of the Higher Education Act, a decision on the admission to study entitles the candidate for admission to the right to enrol in studies within the time limit set by the higher education institution. The deadline for the enrolment has not been established yet, however, based on the experience from previous years, it can be assumed that the enrolment in study in the concerned degree programme will be set for the period from August till October 30th, 2025.

6. Fees

Admission fee

The admission fee is 600 CZK and is payable no later than 3 days after submitting the application. The fee is non-refundable. The payment has to be made via a payment order or via https://eps.vsb.cz. Unpaid e-application cannot be registered in the system.
